a. Peace Together Our Community Townhall Recap

The focus of this workshop was to provide community concerns as identified during the Peace Together Our Community Townhall event as summarized below:

- Questions encompassed employment for more candidates of color and encouraged hiring of candidates that are bilingual and have more experience in cultural differences.
- The goal to expand the hiring outreach and to provide a warm and nurturing environment to candidates of color.
- Provide Micro Aggression training for current staff as a more diverse staff is established.
- Consideration of a third-party service to identify a more diverse candidate for Village vacancies.
- Goals to implement cultural competency training for employees on a regular basis.
- The sharing of information and processes to the community.
- Community safety concerns and how HPPD can assist by creating a community based remote police command center and the possibility of participating in this effort at least a few days a week as well as having officers walking through various neighborhoods and interact with the community.
- The possibility of creating a Police/Citizen's Review Board allowing civilian board members as well as professional members and thus establishing a more transparent review process of police officers when they are at the center of an accusation and/or disciplinary action.
