

Instructions for Beekeeper Permit Application

Please follow these instructions to apply for a Beekeeper Permit. You must provide all of the information requested on the application. Providing false or misleading information is grounds for denial or revocation of permit and removal of hive(s) from the apiary. You will also need to submit copies of several supporting documents, as indicated in the instructions below. There is no fee for obtaining a beekeeper permit.

Note: If there is no space available in the apiary when you apply, you will be informed that you have been placed on a waiting list.

First Time Application

Apply for a permit for the Hanover Park Community Apiary as follows.

1. Print pages 2 and 3 of this packet.
2. Read the Terms and Conditions of Permit (page 2) and initial next to Line #5, indicating that you have read and understood the village's Indemnity and Hold Harmless and Release policy.
3. Complete the Beekeeper's Permit Application (page 3) as follows.
 - a. Place a checkmark on the line next to "First Time Application."
 - b. Provide your full legal name, your home address, and your home, work, and cell phone numbers.
 - c. Provide your e-mail address (if you do not have an e-mail address, write "N/A").
 - d. Indicate the number of hives you wish to keep (note that the maximum number of hives allowed is 2).
 - e. Provide your IL apiary registration number (you have 60 days to provide this number—see application).
 - f. Place a checkmark to indicate your level of beekeeping experience, and provide supporting documentation as follows:
 - i. If you are an *experienced beekeeper*, attach a short description of your experience. Helpful information includes the number of years you have been keeping bees, the number of hives you own, the general location of your hives, and so on.
 - ii. If you are *new to beekeeping*, you must take an approved beekeeping course before your permit can be approved. Classes are offered throughout Chicagoland at different times of the year (usually in Fall or Winter). If you are unsure as to whether a particular class is considered "approved" by the village, contact the apiary manager at bees@hpil.org with the relevant details.
4. You must maintain at least \$1 million in public liability insurance (known in the hobby as beekeeper's insurance). Attach a copy of your liability insurance certificate showing the required coverage for the relevant period (sources of this insurance may be your home insurance provider or your county farm bureau).
5. Provide a copy of your automobile insurance card showing proof of liability coverage.
6. Mail the completed application, including copies of your Drivers License, public liability insurance certificate (beekeeper's insurance), auto insurance card, and statement of beekeeping experience, to:

7. You must first meet with the apiary manager to receive your designated spot for your hive(s) *before* you may set up in the apiary. Contact the apiary manager when you are ready to schedule an appointment.

Renewal Application

Print Pages 2 and 3 of this packet and provide the requested information, as follows:

1. Place a checkmark on the line next to "Renewal Application."
2. Fill out the application as above, noting any changes or updates to your personal contact information.
3. Include a copy of your liability insurance certificate showing the required coverage for the renewal period.
4. Mail the completed application and the insurance certificate copy to the Director of Public Works at the address shown above. **You must submit your renewal by November 30 of each year.**

Terms and Conditions of Permit

The beekeeper (owner) shall:

1. Provide own hives, bees, and equipment, including a source of water. Each owner shall be limited to two hives. The Cook DuPage Beekeepers Association will be allowed additional hives for mentoring, education, and scientific observation. A location to obtain water will be provided. Permittee must maintain the hives in accordance with State regulations 8 Ill Adm. Code, Title 8, Chapter 1, Subchapter 6, Part 60, Bees and Apiaries. Hives may be placed only in designated spots assigned by the apiary manager.
2. Provide constant upkeep and maintenance of hive(s), and have it or them properly identified.
3. Register hive(s) with the Illinois Department of Agriculture, mark the hive(s) with the Illinois Department of Agriculture Apiary Registration Number, and provide a copy of the registration to the village. No bees shall be moved into the Village from outside the state of Illinois or outside of the county without a State permit therefore (a copy of which shall be provided to the Director of Public Works).
4. Demonstrate acceptable beekeeping skills as approved by the Village's inspector.
5. _____ (initial here) The signatory to a permit agrees to save, hold harmless, indemnify and defend the Village, its officials, agents, and employees, from and against all liability, legal action, costs, damages, injury or death, or expenses that may ensue or arise out of or as a result of applicant having bees on Village owned land. The signatory also assumes all risks and loss for whatever reason to applicant, applicant's bees, or equipment concerning applicant's bees, equipment, or applicant being upon Village's premises, and releases and waives any claims or rights against the Village, its officers and agents arising from any reason whatsoever.
6. Obtain and keep current public liability insurance in an amount of at least \$1,000,000, and provide the Village with a copy.
7. Beekeepers shall take steps to prevent or contain swarming.
8. Understand or acknowledge that the Village is permitting you to use Village property as a non-exclusive licensee, and the Village has the right at its will to cause the removal of the hive(s) and yourself for any reason or no reason. The Village agrees to allow for the proper removal of the hive(s), in accordance with State regulations.
9. Understand that the Village may use the Apiary for educational purposes, and that private hives will not be included in these events without the owner's permission.
10. Understand that idling of beekeepers' vehicles is not permitted within the apiary.
11. Notify the Village within 24 hours of a change in contact addresses and phone numbers and provide same, and agree to respond to the site within 24 hours if there is a problem.
12. The signatory may not access the Village's site without Village permission for which applicant shall phone the Village in advance.
13. The Village may cancel the permit or license at any time.
14. Products of the hives (honey, beeswax, etc.) along with any waste shall remain property of the beekeeper.
15. The Village has the right to cause an inspection of the hive at any time. Additionally, the beekeeper will keep a record of hive visits and inspections, and provide a copy to the Village upon demand.
16. No person (other than state or village appointed inspectors in performance of official duties) shall open, inspect, or otherwise disturb any other hives without express written permission from the hive's owner.
